Admissions should start and be completed as per the schedule announced / notified by the State Institute of Vocational Education.

Admission shall be made as per rules. If the rules are not followed the admissions so made are liable to be set aside / disapproved. Besides the managements are liable to be suspended / superceded and the Short Term Vocational Institute be derecognized temporarily / permanently. Principal will be held personally responsible for violation of rules to be followed while making admissions and the management shall not interfere in this regard.

The management is permitted to open the following Short Term Vocational Certificate Courses. The maximum permitted strength in each course is 40 and minimum strength is 10

The management should ensure that no course is started without the minimum strength of 10 per course. And should apply for additional section if the strength beyond 40 per course.

The Short Term Vocational Institute shall function in the existing address and location only and failure to do so will amount to cancellation of provisional Recognition besides disciplinary action.

The permission accorded for a society may be withdrawn if it fails to fulfill or violates the conditions stipulated and fails to comply with the instructions issued for rectifying the lapses out and Short Term Vocational Institute stands disaffiliated.

The recognition is provisional and the matter will be reviewed at the end of the each academic year.

The management is not eligible for any Grant - in aid from the Government either now or in future.

The management is not eligible for any conversion of sanctioned courses. If you want to sanction a new course, you should submit a fresh proposal.
